PARISH COUNCIL MEETING

667. Open Forum – None.

668. District & County Councillor reports – DCC – council tax increased by 4.99%, less revenue received from central govt. generally however £190million of SEND deficit will be paid by central govt. £15million extra borrowing for roads – investment to improve drainage to prevent potholes rather than just patch them. Children’s revenue has increased. Consultation on Libraries Unlimited (now closed) looked at cutting librarians’ hours and increasing volunteers to save money and keep libraries open. SHDC – council tax increased by 2.99%. Currently no news on Slapton Line, awaiting decision from central govt. focussed on improving back roads. Culvert works in Kingsbridge are progressing. Remedial works at Fisherman’s landslip still waiting on legal.

673. Chair’s report – none.

674. Matters for Discussion

- a) Flooding and drainage clearance – Village Farm soakaway overwhelmed by heavy and extensive rain resulting in large volumes of water flowing through the church yard and village. Landowners in discussion re: redirecting water flow. Sandbags have been effective. Rickham cross flooding has been resolved by clearing the buddle there - gate required to obtain future access. Drain at Harbour Watch needs clearing to prevent potential landslip. The Cllrs thanked JM for his efforts managing the buddles and sandbags.
- b) The Old Stable alcohol license – JT left the room during discussion. Temporary license not possible. Cllrs supportive of ON sales of alcohol so long as consumption occurs on site, noise is kept to a minimum and rubbish is managed.
- c) Public Conveniences at Ferry steps - SHDC contacted re: keeping public conveniences open all year round.
- d) Beach Café at Mill Bay – discussion on planning conditions of container at Mill Bay. Cllrs supportive of café at Mill Bay under current conditions.
